- The Omaha Equestrian Foundation (the OEF) is pleased to offer the OEF Grant. This grant will be awarded annually and shall be used to ward expenses for an educational, competitive or other developmental experience. The goal of this grant is to further the OEF mission of growing equestrian sport in our region through education.
- Nominations are due by March 15, 2018
- Any equestrian, parent, trainer or friend may submit a nomination. Individuals may nominate themselves. Individuals under 18 years of age may be nominated with parental consent. For the first year, we plan to keep the eligibility requirements open in order to determine the needs of competitors, trainers and families in our area. However, is will be limited to individuals living in Nebraska or adjacent states.
- Applicants will be informed of the Board's decision no later than April 1, 2018, and the grants will be awarded at the International Omaha Grand Prix on April 15, 2018.
